The Bachelor of Arts (BA) in Economics

Completion of 133 credits comprising

- 24 credits in required common subjects: Chinese Language(4 credits), Foreign Language(4 credits), General Knowledge Courses(16 credits), Physical Education(2 years, 0 credit).
- 59 credits in required major subjects:
 - o Freshman: Principles of Economics(8 credits), Calculus(6 credits), Accounting(Practice of Accounting) (6 credits), Programming for Data Science I(2 credits);
 - o Sophomore: Microeconomics(6 credits), Macroeconomics(6 credits), Statistics(6 credits);
 - o Junior: Public Economics(4 credits), International Economics(4 credits), Money and Banking(4 credits), History of Economic Thoughts(4 credits);
 - o Senior: Business Law(3 credits).
- 50 credits in elective courses, as listed on the course website
 - o Required elective courses for Preparatory Programme: Mathematics for Economics (6 credits); Econometrics (6 credits).

- 5CU Electives, as listed on the course website
- 2CU Open Elective, choose from the following:
 - o Internship or Capstone Project
 - o Electives from MSE/MSFE curriculum
 - o Open courses from other SMU Master Programme
- 1CU of Postgraduate Professional Development
- Minimum CGPA of 2.5 out of 4.0

NTPU students who enrol in the MSE under this agreement will be exempted from taking the 4CU Foundations

The Master of Science in Financial Economics (MSFE)

Graduation Requirements:

Completion of 15 Course Units (CU) comprising

- 4CU Foundations
- 6CU Core, comprising Microeconomics Analysis(1CU), Macroeconomics Analysis (1CU), Econometrics Analysis(1CU), Corporate Finance(1CU), Financial Econometrics(1CU) and Empirical Finance(1CU)
- 3CU Electives, as listed on the course website
- 1CU Open Elective, choose from the following:
 - o Internship or Capstone Project
 - o Electives from MSE/MSFE curriculum
 - o Open courses from other SMU Master Programme
- 1CU of Postgraduate Professional Development
- Minimum CGPA of 2.5 out of 4.0

NTPU students who enrol in the MSFE under this agreement will be exempted from taking the 4CU Foundations
